The Servas country's offer to host looks good, but the pandemic is still casting a shadow of uncertainty with regard to international travel. The Servas country has extended its ban on commercial international flights to the Servas country until Oct 31. Once flights do resume, we can expect a range of vaccine and quarantine rules. We can also expect the Servas country like many countries will allow flights from countries deemed "safe". I suggest we plan for a fully virtual conference in November 2022. We can suggest that we are hoping to run a hybrid virtual and in person conference but at this point we cannot confirm the in-person element. We will notify members of the in-person element as soon as we have confidence that it will happen. Hopefully by early 2022 the options for international travel will become clearer and we can plan an in-person event.
